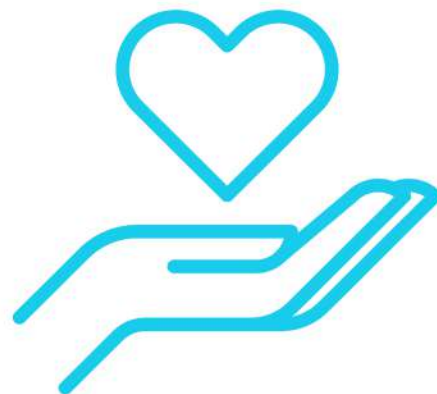

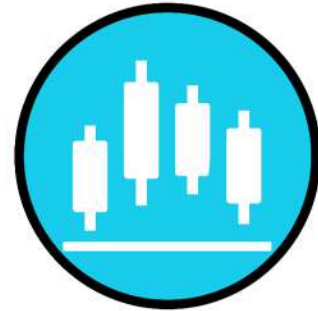

Token Burning Mechanism

- Token burning is a strategic initiative adopted by LOIS Token to enhance scarcity and promote deflationary dynamics within the ecosystem.

Presale Rounds:

- 6% and 14% of the total token supply are allocated in Presale Rounds 1 and 2, respectively.
- Burning occurs proportionally with each sale milestone, contributing to deflationary pressure.

Monthly Burning:

- After Presale Rounds, monthly burning of 0.1% of total supply ensues until reaching a cumulative 3% burning.
- Transparent transactions are regularly published for accountability. Refer to the Project website for more information.

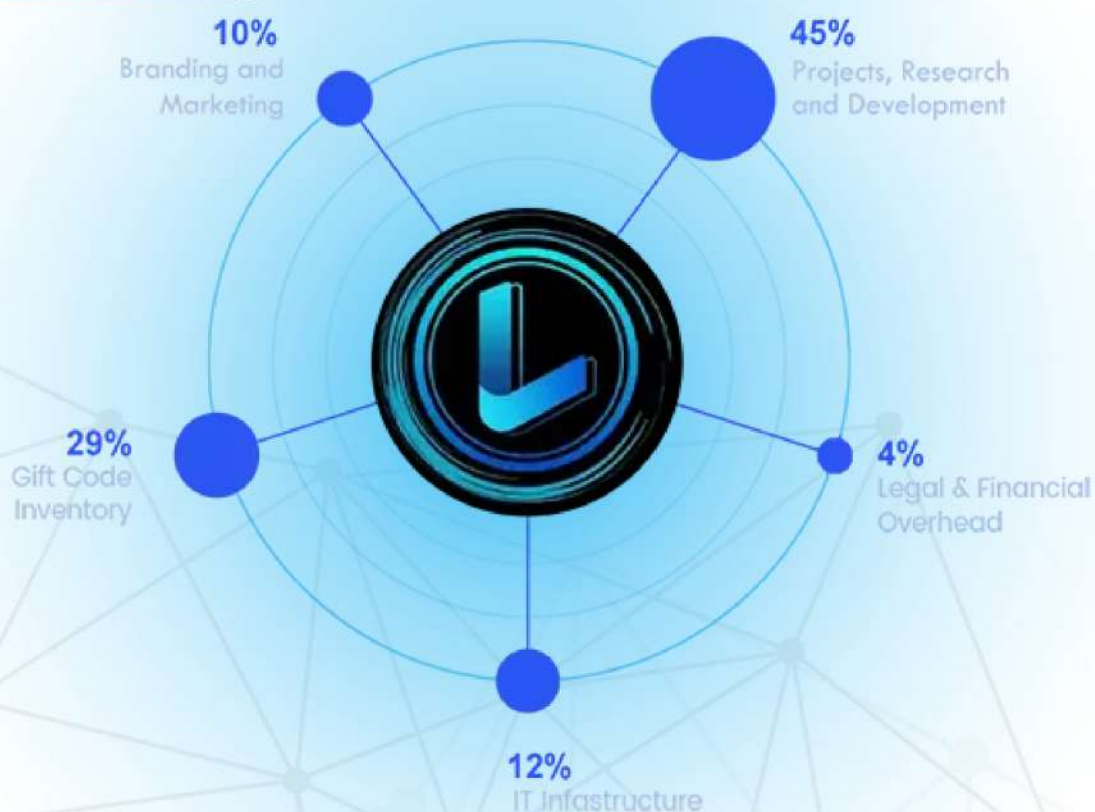
