## ▼ TECHNOLOGY

Open source code of BigBlueButton is used.

The security is already enhanced.

Audio, video, and screen sharing, WebRTC libraries transmit real-time protocol packets (RTP) over user datagram protocol (UDP) via Datagram Transport Layer Security (DTLS), and media packets are encrypted using Secure Real-Time Protocol (see SRTP). This all adds up to a high level of built-in security for streaming.

Face filter (AI software to enhance face image) and background separation through SDK.

Future development is encryption by unhackable blockchain technology.

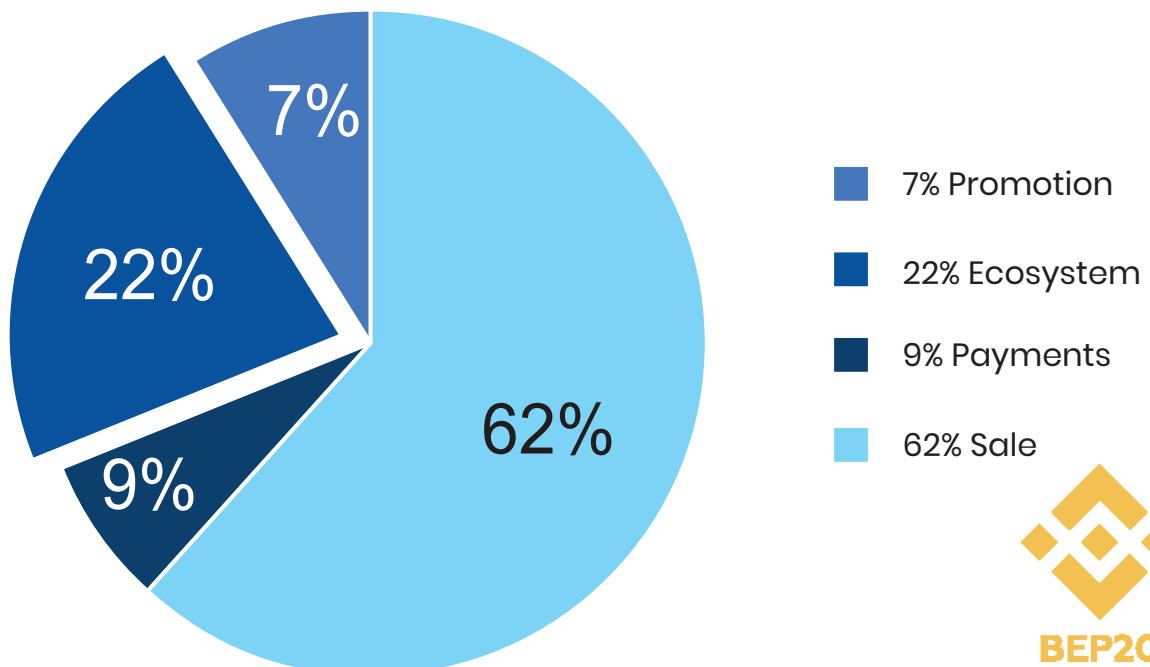

## Enterprise account

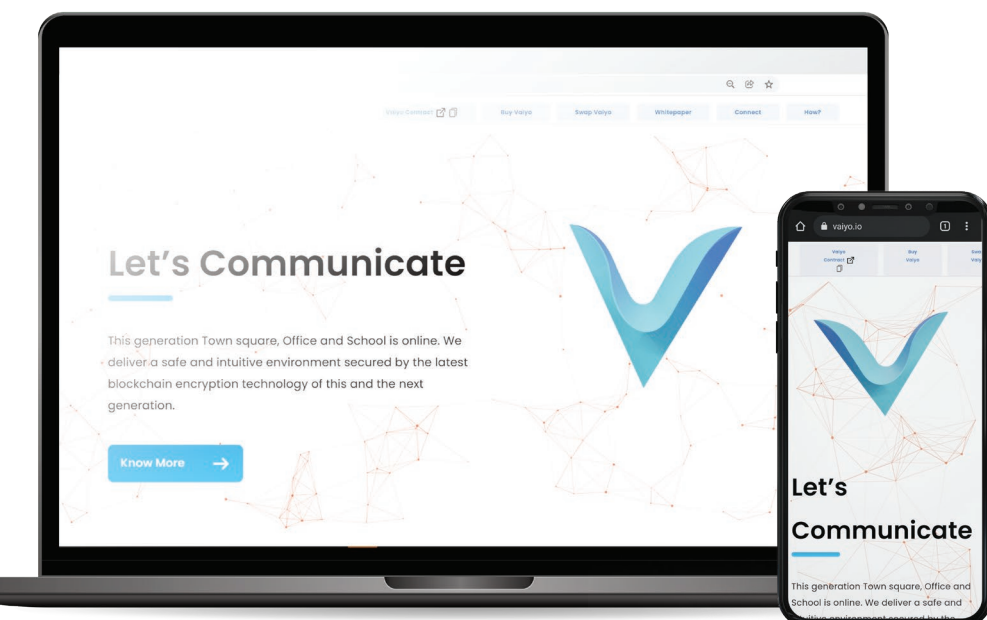
- q Subscriptions for \$80 of Vaiyo tokens a Month, automatic deducted. (live phase, special payment wallet)

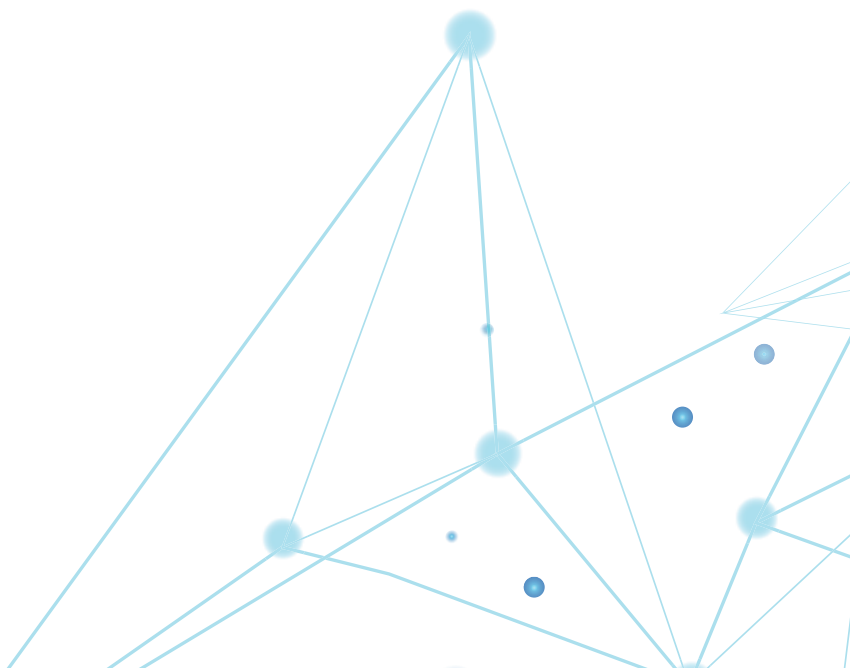
# ▼ TERMS AND CONDITIONS
